- Discussion of annual report
 - Collaboration with StartUp Migrants: 3 preschools: promoting, joining the events and introducing DION (12th of May, 2 last ones in autumn).
 - University Research Council: next slogan for NTNU, high organ. Two weeks before the meeting agenda is sent with case files, a lot of preparation. Physical attendance preferred. PhD funds raised in the council.
 - Innovation Council: prorectors, hybrid meeting, sharing documents in advance, strategies for innovations, funding for preschools. PRORECTOR FOR INNOVATION.

 - Description of events to be found in the annual report.
 - A separate email account used for registrations for the events.
 - Grants: organize events on every campus, specifically for Gjøvik and Ålesund. 2000 NOK for each grant. List of participants, all the receipts, you are being reimbursed after the event.
